

## Objective & Strategy

This certificate is linked to a basket of Swiss shares and one exchange traded instrument. This Active Dynamic Certificate is documentary evidence of a discretionary investment strategy defined by the investment advisor in the "Vandaalen Swiss High Dividends Equities" sphere.

The underlying is usually composed of at least 5 and up to a maximum of 30 securities (but may also have a cash component of a certain amount) from the investment universe, whereby the weighting of any security may not exceed 30 percent at the time of the investment. Short selling is not permitted. All the funds must be invested in basket components of the investment universe at all times.

## Monthly Comment

In January, the Swiss High Dividends certificate registered a performance of -0.48% compared to December's 0.4%. The certificate's benchmark, the Swiss Market Index (SMI), rose by 0.10% against 0.83% in the previous month. Since the beginning of the year, the two baskets stand at -0.48% for the certificate and 0.10% for the benchmark. Since inception, cumulated performances are respectively at 24.60% and 19.78% (annualized performances of 4.18% and 3.52%) for annualized volatilities of 10.14% and 11.57%.

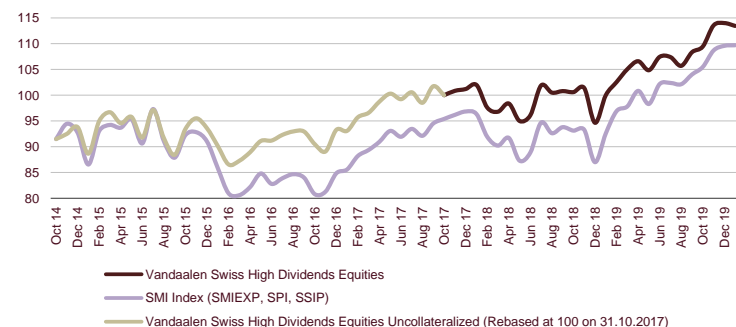
During the month, we added two positions: Richemont (1.87%) and Landis (1.05%). Other changes included the reduction of our exposure in ABB, Novartis, Roche, SGS, Swiss RE and UBS. Therefore, health care companies account for 32.28% of the portfolio, followed by financials at 16.98%, industrials at 14.17% and consumer discretionary at 4.95%. Cash is now at 25.72%.

Best contributors to the performance were Roche (+3.28%, +0.48% contribution), SGS (+5.28%, +0.11% contribution) and Swisscom (+3.31%, +0.11% contribution). On the other side, Dufry (-12.78%, -0.27% contribution), Ascorm (-9.03%, -0.13% contribution) and Richemont (-7.12%, -0.13% contribution) were the main detractors.

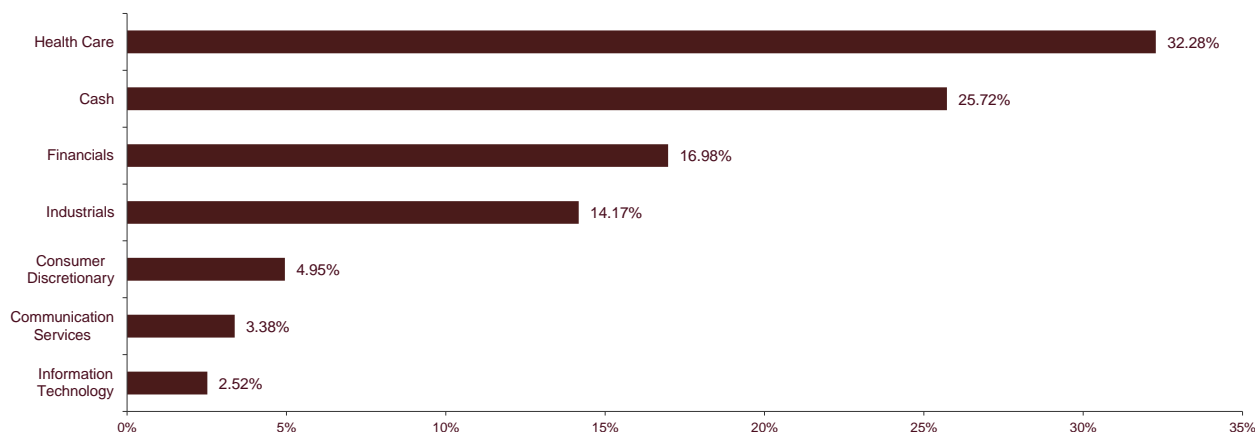
